CH_2O Boiler Treatment Products are designed to reduce many of the inherent problems associated with steam boiler applications.

No chemical product can completely eliminate waterrelated problems; results are dependent on several factors including maintaining proper chemical residuals, system operation, design, cleanliness, metallurgy, and water quality. For optimal results the following actions should be taken by qualified operational personnel:

Product **6276A** is a highly concentrated one-drum boiler compound that incorporates POSCA inhibitors. It is well suited for mechanically deaerated feedwater with high to moderate alkalinity. A volitalizing amine is added to aid in neutralizing carbonic acid in condensate systems.

SAFETY & HANDLING PROCEDURE

This product is a moderately alkaline liquid. It can be safely handled using standard precautionary procedure associated with industrial chemicals of this type. Avoid prolonged or repeated contact with product.

FEEDING TECHNIQUE

Pump directly into the makeup water line of the boiler or add via a one-shot or bypass feeder. It can also be added to a chemical feed tank or condensate receiver.

DOSAGE

Initially charge the system at a rate of 25.6 fluid ounces per 1,000 gallons of water. Reduce maintenance feed rate with respect to the cycles of concentration being maintained.

CONTROL

Maintain a residual of 6 to 15 parts per million of POSCA in the system at all times as tested by CH_2O 's **P-2** test kit. Consult your CH_2O representative for testing options and residual parameters specific to individual systems. Daily testing is necessary for best results. Daily testing is recommended to maintain proper control. Failure to monitor and maintain treatment levels can cause damage. In addition to monitoring and maintaining treatment levels, it is the customer's responsibility to ensure the product is fit for its intended application.
