#### **APPLICATION**

CH<sub>2</sub>O Cooling Water Treatment products are designed to reduce generalized corrosion and mineral deposition in evaporative cooling systems. Excessive corrosion can result in loss of system integrity and mineral deposits reducing system efficiency.

Product performance is dependent upon maintaining proper chemical residuals, system operation, design, cleanliness, metallurgy and water quality. For optimal results the following actions should be taken by qualified operational personnel:

- · Initial system cleaning and passivation;
- Periodic inspections of all system components;
- Maintaining systems free from particulate matter and sludge accumulations;
- Insuring proper chemical feed rates and system bleed-off;
- Control of biological organisms accompanied by periodic biological testing; and,
- Daily testing and recording of chemical residuals.

If problems are encountered maintaining product residuals, additional analytical testing may be required. At your request a CH<sub>2</sub>O Water Treatment Specialist may assist in performing these services.

**6330** is formulated for evaporative/recirculating water systems as part of the mineral precipitation control program. This formula gives excellent performance over a wide array of make-up water conditions and it is an excellent choice for higher silica conditions

A fluorescent dye has been included in product **6330** as a tracer. The tracer dye is easily detectable on instrumentation to determine treatment levels.

ORGANIC FORMULATION – 6330 is formulated with all organic compounds. It contains no heavy metals, phosphate, or molybdate.

#### **SAFETY & HANDLING PROCEDURE**

**6330** is slightly acidic. Safety gloves and goggles must be worn when handling the product concentrate. Solution can be safely handled using standard precautionary procedure associated with industrial chemicals of this type. Read and understand the SDS before handling this product.

## **FEEDING TECHNIQUE**

Inject directly into the condenser water recirculating line or the basin of the cooling tower in an area of high dispersion.

#### CONTROL

Maintain a residual of 20 to 40 parts per billion of PTSA dye in the system at all times, as tested by the Opti-Check hand-held fluorometer or the Little Dipper in-line fluorometer. Or, maintain a residual of 3 to 6 parts per million of active POSCA in the system at all times, as tested by  $\text{CH}_2\text{O}$ 's **P-2** test kit. Contact your  $\text{CH}_2\text{O}$  representative for further information testing and instrumentation.

Daily testing is necessary for best results. Daily testing is recommended to maintain proper control. Failure to monitor and maintain treatment levels can cause damage. In addition to monitoring and maintaining treatment levels, it is the customer's responsibility to ensure the product is fit for its intended application.

#### DOSAGE

Initially charge the system at the rate of about 24 ounces per 1,000 gallons of system capacity. Maintain system treatment by feeding product **6330** at the rate of about 6 ounces per 1,000 gallons of makeup water.
