A-WALL BAY & WALL CLEANER

TYPICAL APPLICATIONS

The unique blend of organic and inorganic soils that deposit in the bay and on the bay walls in a car wash is quite difficult to remove with general cleaning agents. **A-WALL** is formulated for use in this application. **A-WALL** is a self-foaming, acid-based cleaner that can be applied with a pump-up sprayer or bucket and brush.

A-WALL should not be applied to glass as etching can occur. If the product does contact glass, prompt water rinsing will inhibit etching. The product should always be diluted before application to surfaces of an inorganic nature (ceramic tile, cement, etc.); do not allow product to dry on these surfaces or damage may occur.

DIRECTIONS FOR USE

A-WALL should be diluted before use. **A-WALL** may be applied at the rate of 1 part product to 32 parts water for general maintenance or as strong as 1 part product to 10 parts water for heavy-duty cleaning. The diluted solution can be sprayed on the dirty surface, by drenching from bottom to top, then down again to the bottom. Alternately, the solution can be applied manually by brush-washing in the same bottom-to-top fashion. After 3 to 5 minutes, before the solution begins to dry on the surface, a similar bottom-to-top rinse with fresh water should be applied to leave a clean and bright surface.

NOTE: See above cautions with reference to glass and inorganic surfaces.

FREE RINSING

Select wetting agents in **A-WALL** provide excellent lubrication and rinsing ability, yielding an even shine.

SAFETY & HANDLING PROCEDURE

A-WALL is an extremely acidic solution. Complete safety protection must be worn when handling the product. Eye exposure will cause permanent eye damage; splash-proof eye protection must be worn when handling. Skin exposure will cause irritation and/or burning of skin; rubber apron, boots and gloves must be worn when handling. Prolonged or repeated contact may cause irreversible damage to exposed area. Respiratory protection required if the TLV of the product or components thereof are exceeded. Refer to MSDS for complete safety and handling techniques.
