ALKA-SAFE 970NF is acceptable as a general cleaning agent on all surfaces, or for use with steam or mechanical cleaning devices in all departments of official establishments operating under the federal meat, poultry, shell egg grading, and egg products inspection programs.

Chelants and wetting agents in ALKA-SAFE 970NF are carefully selected to provide excellent rinsing ability and inhibit the formation of calcium carbonate (CaCO₃) precipitate in the rinse cycle.

SAFETY

ALKA-SAFE 970NF is moderately alkaline. Wear goggles and rubber gloves when handling this product. While making use-solutions do not add to strong oxidizing agents such as chlorine.

GENERAL DIRECTIONS

ALKA-SAFE 970NF can be applied by manual methods as in general housekeeping operations. Dilute 1 ounce with 1 to 2 gallons of water at temperatures up to 120°F. In high-pressure spray cleaning of CHP systems, a dilution of 5 pounds per 50 to 100 gallons of water at temperatures up to 140°F is recommended. To manually clean small parts and utensils use 1/3 to 1 ounce per gallon of water at 130°F depending upon the degree and type of soil. For cleaning painted surfaces use 1/3 to 1 ounce per gallon of water at 120°F to 160°F. cleaning solution by brush, mop, or spray. Wash walls from bottom to top to avoid streaks on painted surfaces. Rinse cleaned surfaces with fresh water.
