Dilute 6-8 ounces (120 ml) of **CLEAN-IT H** to 1 gallon (3.8 liters) of water.

**For General Cleaning:**

Dilute 2 to 3 ounces (60-90 ml) **CLEAN-IT H** to 1 gallon (3.8 liters) of water.

**For High Pressure Washing:**

Dilute 1 ounce (30 ml) **CLEAN-IT H** to 1 gallon (3.8 liters) of water.
