TYPICAL APPLICATIONS

EVER-KLEEN 9243 is recommended for the removal of grease, wax, oily films and other dirt and grime on food processing equipment and structures. It can be used on steel, tile, rubber, plastic, and soft metal* surfaces.

EVER-KLEEN 9243 is a concentrated liquid cleaner which can be accurately and efficiently dispensed through automatic feed and control systems. It has been formulated specifically for effective cleaning and degreasing at low use-solution concentration. The result is a low-cost cleaner with optimum performance.

EVER-KLEEN 9243 provides a copious amount of foam to aid in soil penetration during cleaning. High foam levels promote cleaning solution contact in upper portions of conveyors and vessels.

The chelates and wetting agents in **EVER-KLEEN 9243** are carefully selected to provide excellent rinsing ability and inhibit the formation of calcium carbonate (CaCO₃) precipitate in the rinse cycle.

EVER-KLEEN 9243 is acceptable as a general cleaning agent on all surfaces, or for use with steam or mechanical cleaning devices in all departments of official establishments operating under the federal meat, poultry, shell egg grading and egg products inspection programs. After use, a potable water rinse is required.

*Test specific use concentration in a small inconspicuous area for compatibility before use.

SAFETY AND HANDLING

This product is an alkaline liquid. Review and understand the SDS before handling to ensure the necessary personal protective equipment is employed during use.

Do not add strong oxidizing agents such as chlorine to the concentrated product.

GENERAL DIRECTIONS

EVER-KLEEN 9243 can be applied by manual methods as in general housekeeping operations. Dilute 1 part **EVER-KLEEN 9243** with 20 to 60 parts water at up to 120°F.

In high pressure spray cleaning of COP systems, use 1 to 2 ounces **EVER-KLEEN 9243** per gallon of water at 140°F to 160°F.

For foam generating, use **EVER-KLEEN 9243** at 2 to 4 quarts per gallon of water at 120°F to 160°F. Brush, or spray the solution. Wash wall from bottom to top to avoid streaks on paint.

Rinse solution from surface after application.
