APPLICATION

Many types of modern ultra-filtration membranes are routinely clogged by the organic materials and Calcium hardness found in the food substance being processed. Regular cleaning of UF membranes is needed to ensure good permeate flow-rates and low back-pressures.

FILTRON A is an alkaline, chelated powder that has been designed for use as a membrane cleaner in dairy and food processing plants.

FILTRON A is acceptable for use in food processing plants where FDA regulations apply.

SAFETY & HANDLING PROCEDURE

This is an extremely alkaline product. Contact with skin will cause severe burns. Protective clothing and safety equipment must be worn when handling this product. Read the product label and SDS for complete handling instructions before using this product.

FEEDING TECHNIQUE

FILTRON A must be gently added to cold water, with vigorous mixing, to avoid the generation of heat and/or spattering. After the product is completely dissolved, heat may be applied to warm the cleaning solution to the desired temperature. Consult your CH₂O representative for additional details.

CONTROL

Maintain a use-solution of 0.15 to 0.6% causticity. For information about times and temperatures and use-solution strength of UF cleaning, contact your CH₂O representative.

Analytical testing is recommended to maintain proper control. Failure to monitor and maintain treatment levels can cause damage. In addition to monitoring and maintaining treatment levels, it is the customer's responsibility to ensure the product is fit for its intended application. Additional testing may be performed upon request.

DOSAGE

Mix 1 quart (volume) or 2 lbs. of **FILTRON A** per 100 gallons of water to make a use-solution of 0.15% causticity. Mix 1 gallon (volume) or 8.3 lbs. of **FILTRON A** per 100 gallons of water to make a use-solution of 0.6% causticity. Contact your CH₂O representative for assistance in selecting mixing equipment for making cleaning solutions from powdered products.
