## **APPLICATION**

**NITRO-CLEAN** contains an acidic pH adjusting material that will lower pH of system water.

## **SAFETY & HANDLING PROCEDURE**

This product is a highly acidic liquid. Chemical splash goggles and impervious gloves should be worn during all handling of the concentrate. Refer to the Material Safety Data Sheet for further safety and handling procedures.

## **FEEDING TECHNIQUE**

Inject directly into the irrigation lines using CH<sub>2</sub>O automated metering equipment.

#### **CONTROL**

Maintain your desired pH. Daily testing is recommended to maintain proper control. Failure to monitor and maintain treatment levels can cause damage. In addition to monitoring and maintaining treatment levels, it is the customer's responsibility to ensure the product is fit for its intended application. Additional testing may be performed upon request.

#### DOSAGE

A control test is recommended on individual plant species to determine tolerance.
