POLY-FLOC 50 is an inorganic liquid coagulant that can be used for water clarification. It is effective for clearing muddy water caused by colloidal clays, or other solids in the water. POLY-FLOC 50 may be used alone or in conjunction with other polymers for improved clarification.

POLY-FLOC 50 is highly charged, enabling less product to do more. Advantages over other coagulants include the following: reduced sludge; superior finished water quality; improved performance in cold water; and minimized pH adjustment.

**POLY-FLOC 50** is a versatile, multipurpose coagulant suitable for a wide array of applications.

**POLY-FLOC 50** should be fed straight without dilution. A diaphragm metering pump of non-corrosive material is suitable.

## **STORAGE**

Aluminum, copper, brass, zinc, and iron equipment should not be used in storage or feed systems.
