RE-SOLV SELF-FOAMING ALKALINE CLEANER HELPS REMOVE DRIED PHENOLIC RESIN

Phenolic resin/glue is a wonderfully strong adhesive, which is used extensively in a variety of applications. Because of its strong adhesive properties, cleaning residues after application can be a challenge. **RE-SOLV** is specifically formulated for this application.

HIGH-FOAMING

RE-SOLV is formulated to be a self-foaming product when applied through an air spraying system.

GENERAL USE DIRECTIONS

RE-SOLV is a concentrated product and should be diluted between 1:1 or 1:2 with water before use. To make the use-solution, add water to the air assisted foam tank first and then add product to the water. Stir the solution gently to ensure excess foam is not generated. Product may also be metered through an air assisted foaming station for greater ease of use. Spray use-solution onto the areas to be cleaned ensuring the foam reaches and clings to all dirty surfaces. Use a non-abrasive brush to scrub the areas for approximately one minute (longer for baked on residue). Allow the product to remain on the surface for at least ten but no more than twenty minutes before rinsing off completely.

SAFETY & HANDLING

RE-SOLV contains sodium hydroxide and can cause burns to skin and eyes. If sprayed, it can cause lung irritation or burns. It is important to read and understand the SDS for this product before using it, and to employ all required personal protective equipment.

When diluting to make use-dilution, slowly add product to the surface of water while mixing gently in order to avoid splattering.

A control test is necessary for individual application to determine tolerance and compatibility. Test pH of the clean surface to ensure it has returned to normal. A final rinse at pH of 5 may be performed if allowed by the manufacturer.
