# SANIONIC 859 Low Foam, Acid Anionic Cleaner

## **TYPICAL APPLICATIONS**

**SANIONIC 859** is a low-foam, final acid anionic rinse for use in the beverage and food industries. It is a blend of phosphoric acid and anionic surfactants that is unaffected by organic soils.

**SANIONIC 859** will not produce excessive foam when recirculating through CIP systems. Cleaning systems with the product on a daily basis will leave equipment in an acid condition that will minimize water spotting, mineral build-up, and corrosion.

**SANIONIC 859** can also be used as a part-soaking solution. If the soaking solution is kept at or below a pH of 3, **SANIONIC 859** will remain effective for a week at a time and not require recharging to eliminate spotting and remove odors.

#### **DIRECTIONS**

Brewing Tanks, Milk Tanks, Bulk Tanks: Once equipment has been cleaned, make up a final acid anionic rinse of 1 fluid ounce SANIONIC 859 per three gallons of water. Circulate for at least three minutes at room temperature. Allow solution to remain in system, or drain as desired. Rinse with potable water and sanitize system in accordance with local health regulations just prior to start-up.

**General CIP:** After cleaning, circulate a 1 ounce **SANIONIC 859** per three gallons of water solution for two to three minutes at 100 to 130°F. Drain system and

rinse with potable water. Sanitize system in accordance with local health regulations just prior to start-up.

**Parts Soaking:** Hand-wash and rinse parts, then place them in a pail containing 1 ounce *SANIONIC 859* and three gallons of water. Soak for at least five minutes, then remove and reassemble equipment. Sanitize system in accordance with local health regulations just prior to start-up.

#### **SAFETY & HANDLING PROCEDURE**

This product is very acidic product. Contact with the material will cause severe burns; prolonged contact with material will destroy tissue. Complete safety gear must be worn when handling this product (impervious gloves, safety goggles and face shield, protective clothing, boots, and respiratory protection) to minimize contact.

**CAUTION:** When added to water, **SANIONIC 859** will reduce pH level. As such, it may cause damage to soft metal or other components. The customer should consult the equipment manufacturer to ensure compatibility prior to addition.
