

SURE FLOW® FS**ANTI-FOULANT****APPLICATION**

Mineral crystallization in irrigation networks may often lead to plugging of nozzles, emitter tips and clogging of sand filters. The use of strong mineral acid washes has proven to be detrimental to pressure compensators and often impractical in removing deposits. Other disadvantages of strong mineral acids include costs and hazards of handling, storage and disposal.

One approach to addressing mineral deposits is to treat the water system with a material that alters the formation and growth of hard crystalline deposits. **SURE FLOW FS** is a water treatment product that causes mineral crystals to deform and become highly irregular. The distorted crystals are powdery in nature, which reduces accumulation of crystalline mineral deposits that can restrict and plug emitter nozzles.

SURE FLOW FS is specifically formulated for use as part of a system that has proven highly effective at inhibiting mineral fouling.

SURE FLOW FS allows simple on-site generation of a chelant compound. Your program is designed and managed for optimum system performance.

SAFETY & HANDLING PROCEDURE

This product is a moderately acidic liquid. Chemical splash goggles and impervious gloves/clothing should be worn during all handling of the concentrated product to minimize skin and eye contact.

FEEDING TECHNIQUE

Inject directly into the irrigation lines using CH₂O automated metering equipment. Never mix this product with other products without the use of properly tested metering equipment.

CONTROL

Daily testing is recommended to maintain proper control. Failure to monitor and maintain treatment levels can cause damage. In addition to monitoring and maintaining treatment levels, it is the customer's responsibility to ensure the product is fit for its intended application. Additional testing may be performed upon request.

DOSAGE

Use only with CH₂O operating equipment. A control test is necessary for individual applications to determine tolerance. Customers shall set treatment levels based on their control test results.
