

# SCREEN KLEEN 101

## POWDERED, ALKALINE SMOKE HOUSE CLEANER

### TYPICAL APPLICATIONS

**SCREEN KLEEN 101** is recommended for use in routine cleaning of smoke house equipment.

### CONCENTRATED

**SCREEN KLEEN 101** is a concentrated cleaner that allows low use-solution concentrations.

### GENERAL DIRECTIONS

#### ROUTINE SMOKE HOUSE USE:

For routine cleaning, use **SCREEN KLEEN 101** after each batch from the smokehouse.

1. Rinse the smoke house screens with hot water.
2. Use .5 to 1 oz. **SCREEN KLEEN 101** per gallon water at 120 -140° F for 45 minutes.
3. Recirculate the **SCREEN KLEEN 101** use-solution through the [vertical screen washer](#), filling the tank to just below the oil skim outlet.
4. After the screens are washed, remove them from the screen washer. Rinse screens with cold water and place them in the smokehouse racks, or store on the screen washer holding pegs.
5. Open the oil skimmer valve and drain fats into a plastic bucket with "Pig Pad" absorbant (or equivalent) to keep them out of the drains.

After cleaning the screens, you may place smoke sticks, rods, or miscellaneous parts in the optional stainless steel baskets, and place them in the screen washer tank. Recharge with only 1 pound of **SCREEN KLEEN 101**, recirculate for 30 minutes while tank solution is still warm, pull parts out and rinse with cold water.

By following this program you can eliminate the buildup of fats, proteins and carbon on the smoke house screens and mats. **SCREEN KLEEN 101** is a superior rinsing product, and leaves your screens and mats perfectly clean. Routine checking with a few drops of Phenolphthalein will validate your cleaning process if no "purple discoloration appears, indicating the surface is free of chemical residue.

Once put into solution, this product will liberate oxygen; solutions should be used directly after making them to ensure maximum product efficacy.



### SAFETY & HANDLING PROCEDURE

This is an alkaline product. Wear safety glasses/goggles and impervious gloves when handling this product and solutions thereof. Do not add **SCREEN KLEEN 101** to strong oxidizing agents, such as chlorine. Read the Safety Data Sheet before handling this product.
