DIRECTIONS FOR USE

UK-110 is a powdered material and must be diluted in water before use. Dilute **UK-110** at the rate of 1/4 to 1/2 cup per gallon of water depending on amount of cleaning desired. Apply solution to entire area being cleaned, use more liberally in heavily soiled areas. Brush or scrub as required. Allow solution to remain on surface to penetrate soil, but do not allow to dry. Rinse solution and debris from surface with fresh water.

Select wetting agents in **UK-110** provide excellent rinsing ability, yielding a superior shine.

SAFETY & HANDLING PROCEDURE

UK-110 contains alkaline salts and surfactants. Safety glasses and impervious gloves should be worn when handling the concentrated product. Impervious gloves should be worn for prolonged or repeated exposure to product use-solutions.

UK-110 can be used for various cleaning applications, including cars, trucks, and general purpose cleaning.
