# **GENERAL**

The CDS-2E unit has been designed to deliver the desired dosage of CH2O products listed in the PRODUCTS table consistently and efficiently. More information about our products and equipment is available at www.CH2O.com.

This CDS-2E unit with Walchem controller is capable of both proportional flow and PPM control. With the remote flow board provided this unit can be equipped with a variety of monitoring, control, and safety options. This allows the unit to supply product based on the flow rate of the water system and monitor water system parameters, such as CLO2, pH, ORP, or Chlorine. This unit can also be combined with a cellular modem allowing for remote data access, emailed reports, and safety alarms. Flow meters and saddles are purchased separately based on irrigation size.

# **TESTING REQUIREMENTS**

Customers shall set treatment levels based on their control test results. Daily testing is recommended to maintain desired level control. It is the customer's responsibility to monitor and maintain treatment levels. Failure to monitor and maintain treatment levels can cause damage.

Use only with CH2O chemical products with this equipment.

## PREVENTATIVE MAINTENANCE (PM)

The CDS-2E comes with initial annual maintenance kit that will need to be replenished annually.

Refer to owner's manual for maintenance schedule on each specific equipment component. A general preventative maintenance schedule is provided in the following table.

Pump Heads	Inspect annually replace as required
Check Valves	Inspect monthly replace as required
Back Pressure Valve	Inspect monthly replace as required
Injector Check Quill	Inspect monthly replace as required
