FOAMY-XF4M HIGHLY CONCENTRATED FOAM ADDITIVE FOR USE IN ALKALINE OR ACIDIC SOLUTIONS

CONCENTRATED

FOAMY-XF4M is an extremely concentrated foam generating product, resulting in low-cost use-solutions while maintaining optimum performance.

CONVENIENT

Because **FOAMY-XF4M** is a liquid, it can be dispensed accurately and efficiently through automatic feed/control systems.

HIGH FOAMING

FOAMY-XF4M provides an abundant amount of foaming to aid in soil penetration during cleaning processes. The foam generated from using **FOAMY-XF4M** with lower foaming detergents increases contact and has shown to be useful when cleaning upper portions of conveyors and vessels.

FREE RINSING

FOAMY-XF4M provides excellent rinsing ability and does not promote the formation of calcium carbonate (CaCO₃) precipitate in the rinse cycle.

SAFETY & HANDLING PROCEDURE

While **FOAMY-XF4M** is a relatively inert material, it is suggested that safety glasses and impervious gloves be worn when handling the concentrated product. Read the Safety Data Sheet for further safety and handling details.

TYPICAL APPLICATIONS

FOAMY-XF4M is recommended for generating extra foam when cleaning conveyors, framework, augers, mixers, tile walls, floors, and general food processing equipment.

GENERAL DIRECTIONS

For generating foam: Use 16 ounces (one pint) of **FOAMY-XF4M** in 50 gallons of water that has already been made into a use-solution with an alkaline or acid-based cleaner. Mix well before use.

For manual cleaning of small parts and utensils: Use 1/2 to 1 ounce of FOAMY-XF4M per gallon of 130°F water. Clean parts with this solution, and then rinse thoroughly with fresh water.

For cleaning painted surfaces: Use 1/2 to 1 ounce of FOAMY-XF4M per gallon of 120°F to 160°F water. Brush, mop, or spray solution onto surface to be cleaned. Wash walls from bottom to top to avoid streaks on paint. Rinse with fresh water.

DOSAGE & CONTROL

Daily testing is recommended to maintain proper control. Failure to monitor and maintain treatment levels can cause damage. In addition to monitoring and maintaining treatment levels, it is the customer's responsibility to ensure the product is fit for its intended application.
