### **APPLICATION**

Natural water contains gasses and minerals that can cause corrosion and deposit formation in steam boiler systems. This leads to loss of efficiency and damage from leakage or overheating. CH<sub>2</sub>O Boiler Treatment Products are designed to reduce many of the inherent problems associated with steam boiler applications.

No chemical product can completely eliminate waterrelated problems; results are dependent on several factors including maintaining proper chemical residuals, system operation, design, cleanliness, metallurgy, and water quality. For optimal results the following actions should be taken by qualified operational personnel:

- Initial system cleaning and passivation.
- Maintaining feedwater free of contaminants and particulate matter.
- Insuring proper chemical feed rates and system blow-downs.
- Verifying proper operation of chemical control and pretreatment equipment.
- Daily testing and recording of chemical residuals.

If problems are encountered maintaining product residuals, additional analytical testing may be required. At your request a  $CH_2O$  representative may assist in performing these services.

Product **6658UT** is formulated to meet FDA/USDA food plant requirements for boiler water treatment. Its exceptional ability to hold high concentrations of minerals (such as calcium and magnesium) in solution can minimize damage due to mineral deposit formation. Product **6658UT** is designed to effectively control deposition when parameters are outside normal operating limits, and can happen intermittently in a boiler.

## **SAFETY & HANDLING PROCEDURE**

This product is a moderately alkaline liquid. It can be safely handled using the standard precautionary procedures associated with industrial chemicals of this type. Avoid prolonged or repeated contact with product.

## **FEEDING TECHNIQUE**

Pump directly into the makeup water line of the boiler or add via a one-shot or bypass feeder. Product **6658UT** can also be added to a chemical feed tank.

## **DOSAGE**

Initially charge the system at a rate of 25.6 fluid ounces per 1,000 gallons of water in the system. Reduce maintenance feed rate with respect to the cycles of concentration being maintained.

#### **CONTROL**

Maintain a residual of 30 to 75 ppb of fluorescein dye in the system at all times, as tested on a calibrated fluorometer. Alternately, maintain a residual of 6 to 15 parts per million of POSCA as tested on CH<sub>2</sub>O's **P-2** test kit in the system at all times. Consult your CH<sub>2</sub>O water treatment specialist for further testing information. Daily testing is recommended to maintain proper control. Failure to monitor and maintain treatment levels can cause damage. In addition to monitoring and maintaining treatment levels, it is the customer's responsibility to ensure the product is fit for its intended application.
